# The Pupil Premium and Early Years Premium Provides funding for pupils:

- Who have been in receipt of free school meals (FSM) at any point in the past six year (£1,300 per child x 110 pupils)
- Who have been continuously looked after for the past six months (£1,900 per child x 1 pupil)
- Who are adopted from care under the Adoption and Children Act 2002¹ or who have left care under a Special Guardianship or Residence order (£1,900 per child x 2 pupils)
- For children whose parents are currently serving in the armed forces, or whose parent / guardian is in receipt of a pension from the MoD (£300 per child x 0 pupils)

#### Action:

4B - To ensure above average progress of Pupil Premium children, across the curriculum.

4B - To close identified gaps by making accelerated progress, with the objective of above average being represented by a minimum of 7 'Steps' of progress.

#### Action:

4C - To ensure rigorous focus across the curriculum on the school's 6 Key Priorities for Pupil Premium children across the whole school, by all stakeholders i.e. teachers, Learning Support staff, SLT and Governors etc.

#### Rational:

4C - Enable monitoring which leads to annual reporting of the attainment outcomes of Pupil Premium children.

#### Personal Development, Behaviour and Welfare

5D - For Pupil Premium pupils to have an equal opportunity, within their ability, to develop and grow in preparation for their existing and future outcomes.

#### The Effectiveness of the Early Years Provision

6A - Identify eligibility for Early Years Pupil Premium funding, support applications and to maintain accurate records.

#### Rational:

6A - To secure additional funding for all vulnerable pupils from the very start of their educational journey at Darnhall.

6B - Follow Key Priorities 1-5 with specific focus on Early Years Provision, opportunities and outcomes. **Rational:** 

6B - To close the gap in attainment with National on Entry levels, in preparation for Key Stage 1 learning, matching school's strategic development priorities.
