SCHOOL PERFORMANCE

1. Overview

Governors received an informative presentation on Pupil Progress from Sarah Williams and Natasha Mulholland.

It was reported that half termly meetings are held for 45 minutes to 1 hour with each class teacher and the following matters highlighted:

- a) Target Tracker assessments are used for the core subjects.
- b) Anonymised data was presented for Reading, Writing and Maths.
- c) Attainment in Reading, Writing and Maths was presented and split into groups for Gender, Pupil Premium, Non-Pupil Premium, SEND and Non-SEND.
- d) It was noted that extra provision for Years 4, 5 and 6 will not be in place next year due to funding restrictions.
- e) Progress from Autumn Term 1 to Spring Term 2 was discussed and it was noted that:
 - 1) Children with little or no progress per half term are targeted.
 - A professional dialogue is held with each class teacher on each child. Any barriers to learning are identified and next steps are detailed on the document.
 - 3) Some children are affected by home circumstances and these are recorded to highlight their story.
 - 4) Data is challenged to ensure it is not inflated and a dialogue takes place to ensure judgements are secure.
 - 5) Children stay on Target Tracker and will be targeted until progress is made. If all pupils in a class have made progress, then those with slow progress will be targeted.
 - 6) The More Able pupils can also be targeted children.

A member of staff reported that teachers appreciate the work that SW and NH do and the time they give to all classes.

Governor Question: GD child – what is that?

Answer: This is a child who is working at Greater Depth.

Governor Question: Do you challenge the Greater Depth children too?

Answer: Yes, we want to ensure they reach their full potential. There may also be a child who was working at Greater Depth and has dropped down so we would need to know the reason for that.

Governor Question: How are Age Related Expectation (ARE) and Greater

Depth(GD) translated into the scale scores?





Answer: The Year 6 standard is 100 (ARE) anything at 110 or above is GD. Governor Question: Do you identify GD across Year 6 and do they get a scale score in school?

Answer: No, the scale score is provided on ASP (Analyse School Performance). Governor Question: Does the score normally equate to the same as school? Answer: Yes.

Governor Question: What is the trigger for parental engagement?

Answer: We expect all teachers to have a good relationship with their parents and speak to them either at the door or on the phone. We do not expect teachers to wait until parent's evening to speak to their parents. Parent engagement is added to the Log; however, a change of staff can affect the engagement so that is logged too. Governor Question: At what stage would you expect parents to be told their child was not making progress?

Answer: As soon as it becomes apparent, as the earlier parents are involved the better. Teachers will speak to the parents or ask the Senior Leadership Team to do so. At the most, we would expect parents to be made aware within a half term of any issues. There are two parent's evenings per year plus parents receive a written report.

Governors thanked Sarah and Natasha for their informative presentation.

Governors noted the invitation for the Achievement for All (AFA) launch on 15th May at 3.30pm. All governors are invited to attend.

2. Attendance

The Headteacher reported that she has written to parents as this is the last year a trip will be arranged for those children with 100% attendance. However, an afternoon tea will be held for those pupils with the most improved attendance and all pupils with 96% attendance or above will be entered into a prize draw. Prizes include two bicycles and tickets for trips i.e. the zoo.

The Winsford Education Partnership (WEP) Attendance Policy has been written by the Headteacher as part of a working party and shared with the other schools. The policy has been written to cover Primary and High Schools and the draft will be available shortly.

Kelly Evans, Maths Lead, gave an informative presentation on Maths and distributed a document for governor information which outlined the Key Priorities for 2017/18.

It was reported that a large majority of pupils are in line with National Average (NA).

Nursery - 77% are working At or Above.

Reception - 70% are working At or Above – Priority is to ensure the pupils make good or better progress so ready to enter FS2 at a higher level.

<u>Combined Year 1 (2 classes)</u> - 70% are working At or Above – Priority to improve the attainment of Boys at ARE.

Combined Year 2 (2 classes) - 51% are working At or Above – Priority to improve the attainment of Boys at ARE.

<u>Year 3</u> - 55% are working At or Above – Priorities are to increase the percentage of all pupils exceeding the expected standard, increase the % of boys achieving expected and increase progress of prior disadvantaged low attainers.

Year 4 - 50% are working At or Above - Priorities are as Year 3.

Year 5 - 38% are working At or Above - Priorities as per Year 3 and Year 4

Year 6 - 55% are working At or Above - Priorities as per Years 3, 4 and 5.

For Year 6 there are 7 school weeks left to move the pupils on before they leave for High School.

Impact and Progress documents are available for each year group. Due to the new curriculum there will be a massive focus on reasoning and problem solving and in 2020 all schools will be carrying out times tables testing from 2 times – 12 times. The tests are available online.

The School Improvement Partner, Julia Dowd, has suggested changes and teachers are now given time to walk around school and observe other lessons which is excellent CPD for them.

The Maths Policy has been updated and was included in the pack.

Class pages on the website have links to Maths and there is a Maths tab on the website to help parents support their children.

Governor Question: Are there any vulnerable groups that we need to focus on? Answer: Yes, Year 2 and Year 4.

It was noted that staff find the Maths documents very useful and it follows through each year group. White Rose maths was trialled for one term and teachers loved it so that is in use across the school now. This gives greater depth questions, guided groups etc. Reasoning is becoming embedded this year.

Governors thanked Kelly for her informative presentation.

Sarah, Natasha and Kelly all left the meeting at this point.

13. Overview / Update

- a) A budget has not been set for 2018/19 yet as the school is in deficit and Mark Parkinson cannot agree a deficit budget until a 3-year recovery plan is in place.
- b) A meeting has been held with the Budget Officer, Kristy Gommery, to try and resolve the budget and put a 3-year plan in place.
- c) Some extra funding for Resource Provision that we should have received in 2016, 2017 and 2018 will be coming in and that amounts to £21k.
- d) For 2019/10 and for 2020/21 the budget will be in credit, so the revised budget and 3-year plan will now be emailed to Mark Parkinson for his approval.
- e) Pupil numbers were discussed, and it is hoped that there will be 339 children by the end of the year as 10 children have joined the school this week.
- f) The PAN (Pupil Admission Numbers) had been discussed with Mark Parkinson and he is asking someone to contact the Headteacher to discuss further. *Governor Question: What is the PAN?*
 - Answer: Currently this is 65 and may go down to 45.

 The school will receive some money from the sale of Hand
- g) The school will receive some money from the sale of Handley Hill eventually which will boost the budget.
- h) The next Finance meeting will be held on 25th May and a further update will be given to governors at the June meeting.
